## A. Introduction

1. The ratification (Latin *ratificatio*) of a constitution describes the formal ending of a process of setting a constitution into force by a constituent power. At the same time, the moment of the ratification or a defined date in the near future is regularly set as the legal beginning of the applicability of the newly ratified constitution. The ratification in the sense of this article means the confirmation of a constitution by a duly legitimated power. It is the final, affirmative act of a 'series of acts that lead to the adoption of a new constitution' (Pisarello 11).

2. The ratification of a constitution means to establish, not to alter, a constitution (see → *amendment or revision of constitutions*). Constitution-making and constitution-amending have to be distinguished as a 'qualitative *aliud*' (Schmitt 26). The ratification in this sense only means the initial act of approval, which is characterized by a situation without legal bindings (Winterhoff 131). Whereas the initial act of ratification of a constitution is an original act, the modification or amendment of a constitution regularly remains a derivative act established by the existing constitution (Winterhoff 356 et seq).

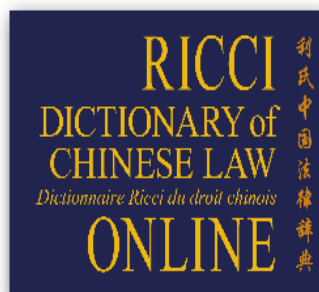

## The Ricci Dictionary of Chinese Law Online (Traditional Chinese – English, French)



The *Ricci Dictionary of Chinese Law (Chinese-English, French)*, developed by [the Ricci Association](#) since 2006, is the very first trilingual dictionary on Chinese law. The dictionary includes approximately 24,000 legal terms in Chinese (legal terms *per se* as well as terms which are often used in a legal context), as well as English and French translations of these terms. A team of around 40 French, Chinese and English-speaking lawyers, scholars, law students and proofreaders contributed to the dictionary under the supervision and guidance of the Ricci Association.

The Ricci Association is a non-profit association, responsible for promoting and developing the “Grand dictionnaire Ricci de la langue chinoise, Chinois-Français” (Le Grand RICCI), the most comprehensive dictionary between Chinese and a western language, first published in 2001 in print format (6 volumes) and then released as a numerical version, available on Brill's China Reference Shelf and on Pleco Software Incorporated. The Ricci Association works on the enrichment of the Grand RICCI database through thematic dictionaries. In this context, the Association launched in 2006 the project of preparing the “Ricci Dictionary of Chinese Law – Chinese-English, French,” encompassing around 24,000 Chinese legal terms translated into French and English, which has been completed in 2016.

The editors have tried to establish a first set of data by gathering existing terms and translations from existing dictionaries. The main dictionaries that have been used for this purpose were the following:

- Grand Ricci dictionary (Chinese-French)
- Hanying Faxue Cidian (Law Press Dictionnary) (Chinese –English)
- Hanying Da Cidian (Shanghai Jiaotong Daxue Press) (Chinese-English)
- A Political and Legal Dictionary published in 1981 in the US by Mr. Bilancia (Chinese-English)
- WTO Law Dictionary (Chinese-English)
